

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.wildheartboutique.com and WildHeart Boutique LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to WildHeart Boutique LLC include www.wildheartboutique.com. The WildHeart Boutique LLC website is a services information site. By using the WildHeart Boutique LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, WildHeart Boutique LLC may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

WildHeart Boutique LLC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Sharing Information with Third Parties

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by WildHeart Boutique LLC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. Security of your Personal Information

- SSL Protocol

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
